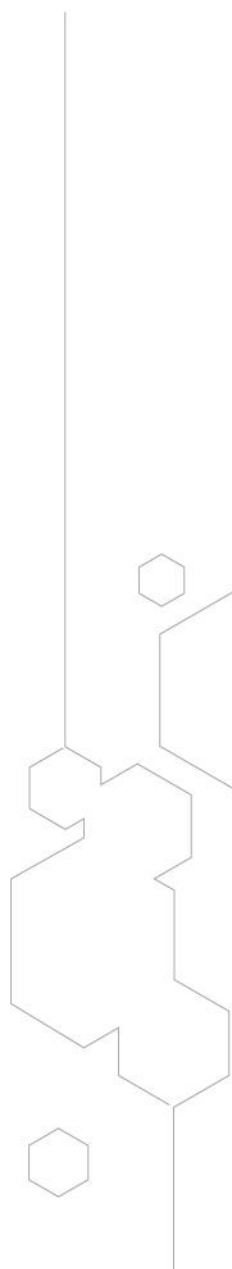

**PARTIES:**

- A. subscription applicant, hereinafter x,  
  
and
- B. Z-Index B.V., hereinafter "Z-Index", located in The Hague,  
represented by Mr J. F. van den Brand

**WHEREAS**

- Z-Index markets G-Standaard, including the Z-Index price list
- x provides and approves the information for G-Standaard via Internet
- x has received a log-in name and password from Z-Index
- the parties must treat the log-in name and password with the utmost care

**HAVE AGREED AS FOLLOWS**

1. x shall guarantee the careful and timely delivery and approval of data.
2. x shall guarantee that the data provided by x it are correct and complete.
3. Z-Index shall only carefully process the data provided by x after they have been approved by x using the applicable procedure.
4. Data approved by x and correspondingly processed by Z-Index shall only be amended by a Z-Index employee based on an emergency procedure and before the final production run. A request for an emergency procedure must be an exception.
5. The emergency procedure shall be started after Z-Index has received a written request from the management of x or an employee authorised by the management of x, which mandate must be verbatim included in the request.
6. x gives Z-Index permission to include the data approved by x in G-Standaard and the products derived from it.
7. Z-Index shall not be held liable for mistakes in the data approved by x and/or for errors in the processing of the data approved by x except in case of wilful acts or gross negligence.

**G-Standaard data entry web portal license terms**

8. x shall indemnify Z-Index for any claims for compensation by x or a third party due to errors in the data approved by x and/or for errors in the processing of the data approved by x. x shall bear the burden of proof in this respect.
9. This agreement shall be governed by Dutch law.
10. A dispute shall exist if one of the parties informs the other one thereof by registered letter. All disputes shall be heard by a board of three arbitrators. Both x and Z-Index shall nominate one arbitrator for this board. These two shall nominate the third one together. The third arbitrator must be a lawyer and shall serve as the chairman. If the two arbitrators nominated by x and Z-Index cannot agree on the chairman, the District Court of The Hague shall nominate the chairman. The board shall make binding decisions and determine the costs.
